David Goldemberg called the meeting to order at 9:01 a.m.

There was no public comment during the public forum.

With no public comment, Supervisor Ryan Campbell made a motion to approve the minutes of the January 29, 2021 meeting, David Goldemberg seconded the motion. The minutes were approved unanimously.

Steve Boyack, Assistant HHSA Director introduced the Groveland Ambulance Parcel Assessment Ballot Measure item and explained the importance of bringing the item to the committee at this time. The time is such that we must ensure it could be on the June 7, 2022 ballot if the committee and Board of Supervisors so choose. He also provided an outline of today's presentation.

Wendy Hoffman-Brady, Assistant Director, HHSA provided information regarding what an Ambulance Enterprise Fund is. It operates like a business and should be able to cover its own expenses. Bill Caldera, Chief Executive Officer-Manteca Ambulance spoke regarding the purpose of the property tax assessment.

Katie Andrews, Emergency Medical Services Coordinator spoke about the County Wide System and Call Volume/Response Times. She reported out regarding the GCSD meeting that occurred last night.

Wendy Hoffman-Brady, Assistant Director, HHSA and Jad Kurdi, Agency Fiscal Officer-HHSA presented information regarding the Ambulance Enterprise Fund Status and impacts of Tax Measure failure. Jad Kurdi also spoke to the shared cost.

Steve Boyack, Assistant HHSA Director spoke to the history of Tax Measures and went into more details regarding impact of Tax Measure failure would reduce the services provided to Groveland. The goal of the assessment would be to provide increased services to Groveland residents.

Discussion ensued.

Recommendation of the Finance Committee is to keep the Groveland Ambulance Parcel Assessment at \$90 for a 5-year extension and present for approval to the Board of Supervisors at their February 15, 2022 meeting.
